
SelCall generates Selective Calling Tones. Select your tone type from the extensive selection of available modes, then touch the button for each tone you wish to send. You can even queue up tones and have them sent in a burst, if you wish. The following tone types can be generated:

- PCCIR
- EIA
- EEA
- CCITT
- EURO
- NATEL


To buy your copy of SelCall, and receive a registration code allowing unrestricted use, please visit the website <http://www.blackcatsystems.com/software/selcall.html> and select one of the purchase options.

This is the SelCall window. There are three panes, Tone, CODAN, and Necode.

In the Tone pane, you can select from the various tone modes using the popup menu. You can click on a button to have that tone immediately played. You can also type in a series of tones, and then click the Play button to have them played as a sequence.




In the CODAN pane, you can send a CODAN call. Enter in the 4 digit address you wish to call (Call ID), and your 4 digit address (Our ID), and select the priority of the message. Normally you leave the Center frequency to the default value of 1785 Hz, only change this if you know that you need to alter the frequencies sent. Then click the Send button to have the call sent.



In the Nocode pane, you can send a Nocode call. Enter in the 4 digit address you wish to call (Call ID), and your 2 digit address. Then click the Send button to have the call sent.

You can click on Acknowledge to have an acknowledge tone sequence sent.
